The Discharge page of the Episodes form now contains dates for all in/out times. Unless the Overnight Parameter in Settings has it's value set to "Y" the Separation Date will automatically reflect the Admission Date.

All Extracts post 01/07/06 will now be based on Separation Date.

As existing Episodes will not have the Separation Date field populated a utility is provided to do this under Advanced>Edit Datasets>Update Separation Date. This utility needs to be run once only.

A strategy to handle differing DVA item codes has been implemented.

In general DVA codes appear to be based on theatre banding, although the majority of hospitals use the same codes for each band this is not universal and some hospitals use codes specific to that hospital only and those codes are item dependant. To better cope with this the following changes have been made.

A hospital can specify its own codes for bands 1,2,3 & 4. Do this by adding the following Parameters in the Settings Table:

DVABand1

DVABand2 DVABand3 DVABand4

Assign each of these parameters the code for that band.

In those cases where there is no direct mapping between Theatre Band and DVA code assign each of those Parameters the value "Blank". This will prevent any codes being printed on the form. The appropriate codes can then be written onto the printed form. A more elegant solution is under investigation.


Under Advanced>Edit Datasets select Local Health Funds. Scroll down to the bottom of the table to the New Record (the one with the "*" next to it:



Enter "OMF" as the Local Code, enter "Onemedifund as the Local Description and finally select OMF using the drop down arrow under Master Code. The record should now look like this:



Exit the Local Health Funds table and under Advanced>Edit Datasets select Grouped Health Funds and again scroll to the bottom to the New Record. Add a new entry by selecting AHS as the Service and OMF as the fund using the drop down arrows next to the fields.



Close the Grouped Health Fund's window and that's it.

This release adds additional functionality to the DVA discharge form, specifically for Tier 1 hospitals. These hospitals provide treatment for DVA patients under contracts with the DVA. They need to use specific DVA codes on the DVA Discharge form. As this is a fairly complex situation the entire way in which DS handles this is described:

- By default the DVA discharge form prints a DVA code as the Item Number in the accommodation section of the form. These numbers are hard coded and are selected based on the Same Day Band.
- The hospital can elect to use an alternate set of codes mapped to the same day band by adding entries into the Settings table as follows:

Parameter	Value
DVABand1	Alphanumeric code or "BLANK" to print nothing
DVABand2	Alphanumeric code or "BLANK" to print nothing
DVABand3	Alphanumeric code or "BLANK" to print nothing
DVABand4	Alphanumeric code or "BLANK" to print nothing

If a DVABandX is not specified then the default is printed

- A MBS Item can also be mapped to a DVA specific code via a table. The table is
 edited via the menu path Advanced>Edit Datasets> MBS to DVA Items. Note that no
 intelligence is applied to the alphanumeric codes, anything can be mapped to
 anything although care must be taken as explained later.
 - When a match is found between the item number and a DVA code the DVA code is used as the Item Number in the Accommodation section of the form. Also if the item has a Service Type of Contract/Bundled then the fee attached to the item is printed as the Total Claimed. No charge will appear next to the item number in the Theatre section of the form.
 - Additional charges for items not part of the contract can appear under Prosthesis. These items must be flagged as Service Type Prosthesis.
 - It is important to note that valid MBS item numbers must still be used. Without them HCP extracts will be incorrect and possibly rejected. So one correct way to setup a Tier 1 hospital would be to create an item number such as 30293C in BC. DS will interpret the "C" suffix as denoting a Contract/Bundled Service Type. Then in DS create an entry in the MBS to DVA Item table mapping "30293C" to the correct DVA code. It is also important that the main bundled item appear first in the BC Invoice if more than one line item is being charged.
 - If a charge is also being made for a prosthesis or handling charge these must be setup in the MBS Items table in DS so that DS knows these charges are for prosthesis. This table is edited via the menu path Advanced>Edit Datasets>MBS Items.
